Fine Policy for Overdue Items Effective Date 12/01/21

Overdue fines are not charged for most items (see table below) checked out at the North Greenbush Public Library (NGPL), regardless of what library* owns the item, what library card was used to check out an item, or where the item was returned. However, Museum Passes and Wi-Fi Hotspots are subject to late fees (see table below).

NGPL card holders are responsible for overdue fines for any item they check out at other libraries within the Upper Hudson Library System (UHLS.) Fines may be paid at any UHLS member library (including NGPL) or online through the patron's library account.

NGPL patrons who do not return an item within 30 days of its due date will be billed for its value (see attached form letter), which is determined when the item is processed into the library's collection. If more than one item is overdue on a given date, the patron will be billed for the total value of all items. If additional items become overdue at a later date, the total value of the additional items will be added to the patron's overdue bill. When the total amount a patron owes exceeds \$10.00, their library privileges will be suspended until the overdue items are returned or the Library is reimbursed for the total value of overdue items. A patron's suspension will be lifted once the overdue items are returned or the overdue bill is paid.

The table below provides the loan periods and fines for various items in the Library's collection.
